1. ****Vehicles used for student transportation must be rated appropriately and insured with a MINIMUM \$1,000,000 Third Party Liability Insurance.**
2. The School District does not accept any responsibility for any damage to the vehicle in the event of an accident, not for deductible, loss of insurance, discount or loss of use.
3. The vehicle will be maintained in a safe operating condition and will be equipped with tires appropriate for winter driver conditions.
4. ***The vehicle must be equipped with seatbelts for each occupant and must be secured when travelling.**
5. I agree to wear a seatbelt and require all passengers to wear a seatbelt.
6. I agree that I will not permit a child under 13 years of age to occupy the front passenger seat of a vehicle equipped with a passenger seat airbag.
7. I agree to operate the vehicle in a safe and legal manner.
8. I agree, for safety and health reasons, not to allow smoking in the vehicle while transporting students.
9. I will not, at any time during my performance as a volunteer driver, imbibe any alcohol beverages or use any restricted substances.
10. I authorize a Criminal Record Check, if required.
11. I agree not to use my cellular phone while I am driving the vehicle.
12. I will provide my driver's abstract, if required.

Notes:

- A. If vehicle as the capacity to carry more than 8 occupants, the driver must have a Class 4 driver's license.
- B. The School District provides Excess Third Party Liability coverage for volunteer drivers and owners while lawfully operating vehicles on behalf of the School District.
